The constitution of the trust shall be as under :

1. N A M E :

The name of the trust shall be JAGRITI CHARITABLE TRUST:

2. PRINCIPAL OFFICE :

The principal office of the trust shall be at A-64, RAMGANGA VIHAR MDA Phase-II, MORADABAD.

3. JURISDICTION :

The jurisdiction and the area of activity of the trust shall extend to whole of India.

4. AIMS AND OBJECTS :

The aims and objects of the trust shall be as follows:

- 4.1 To promote educational activities in the area and to establish series of Educational, Technical, Scientific, Managerial & Medical Institutions where boys and girls of all sections of the society get good education of high order, to enable them to become better citizens of the country.
- 4.2 To open and promote Schools, Colleges and Training centers with up-to-date modern facilities to impart education for boys and girls.
- 4.3 To open vocational and professional colleges for higher education and for those who wish to seek proficiency in a particular field of education in healthy atmosphere.
- 4.4 To secure to the future citizens good education facilities from the lowest to the highest stage for their physical, mental, intellectual, spiritual and social development.
- 4.5 To secure to the common people appropriate Vocational, Industrial and Technical education at various levels in order to make them economically self-supporting.
- 4.6 To seek collaboration from renowned brands for schools, colleges and other professional vocations for quality education and instant recognition.
- 4.7 To explore the capabilities and aptitude of the students and impart education and training in the field of their interest and to prepare them for administrative, business management, defense, or other competitions for higher studies or services.
- 4.8 To lift the public from the curse of Poverty, hunger, illiteracy and diseases by starting and carrying out concentrated and intensive programs.
- 4.9 To promote such activities as may result in mental or physical well being of the members of the Society in general.
- 4.10 To grant stipend, scholarship or any other assistance to deserving students for their further study.
- 4.11 To provide all required facilities/aid to disabled needy persons of the Society.
- 4.12 To provide temporary accommodation to needy persons like as old, sick, discarded and helpless persons.
- 4.13 To take financial assistance from Govt. or Public for benefiting common people and to achieve the objects of Trust.

4.14 To establish & run Ashram, Dharamshala or old age home for Senior Citizens and to arrange programs for their welfare and entertainment.

4.15 To do all necessary things for and incidental or conducive for the attainment of above objectives of the Trust.

5. TRUST PROPERTY/FUNDS :

5.1 The aforesaid sum of Rs. 30000/- (Rupees Thirty Thousand Only), as vested by the trustees, will be the initial fund of the trust. Any further sum received in the form of money or in kind or any movable or immovable property from any person(s) by way of donations, gifts, grants etc. or be acquired by any other mode, either as corpus fund or others, for the advancement and furtherance of the aims and objects of the trust, will be the property of the trust.

5.2 Funds of the trust shall include any profit, income or accretions to the same.

5.3 Trustees may raise loans from any person, bank or financial institutions etc. at reasonable/market rate with mutual consent and as per prior decision of the board, if necessary for attainment of the objects of the trust.

5.4 The property of the trust shall vest in the trustees only.

5.5 The founder trustees shall have the power to invest the trust fund as considered proper and beneficial for the trust. They may utilize any of the trust fund investment for purchase of immovable properties for the benefit and/or the objects of the trust or vice-versa.

5.6 The funds of the trust including any profit, income or accretion to the same not immediately required for the purpose of the trust shall be accumulated in the manner as may be decided by the founder trustees and in no case shall be given to the trustees or other persons for their personal use and also shall not be distributed. No part of the trust fund, either the corpus or the income there from shall be utilized for any purpose other than the objects of the trust hereby created.

6. BOARD OF TRUSTEES :

The administration, management and control of the trust and its properties shall vest in the hands of a committee to be called the "Board of Trustees", consisting of at least six and at the most nine persons for the time being. "Board of Trustees" consists- All Founder Trustees and three other trustees, to be appointed by the founder trustees with two-third majority.

7. CATEGORY OF TRUSTEES :

- 7.1 Founder Trustees - Persons who have signed this deed are the Founder Trustees of the Trust. Their membership is for life. They have the right to declare their heir who shall become a trustee of the trust after his/ her death, such heir shall be treated as Founder Trustee. They (Heir) also shall have the right to declare their heir and this chain shall continue forever. In case Founder trustee does not appoint his/ her heir during his/ her life time, his/ her place shall be taken by his / her first elder legal heir. Chairman, Vice-Chairman, Secretary, Joint Secretary and Treasurer shall always be among the Founder Trustees.
- 7.2 Co-opted Trustees - With the unanimous consent of Founder Trustees, any Person who may give his/her valuable services to the Trust or has fame in providing services for attainment of the objects of the Trust, may be co-opt as Trustee of the Trust.
- 7.3 Life Trustees - With the unanimous consent of Board of Trustees, any person who may provide funds, movable or immovable property or other valuables to the trust & has interest in aims and objects of the trust may become the life Trustee of the trust.
- 7.4 Patron Trustee :- Besides other trustees, the Board shall have the right to appoint any person of good repute, who is valuable for the trust to achieve the objects of the trust, can be appointed as Patron Trustee.
- 7.5 Trustees of clauses 7.2, 7.3 or 7.4 shall have no right to appoint their legal heirs like founder trustees.

8. TERM OF OFFICE OF THE TRUSTEES :

- 8.1 The term of the Founder trustee or Life trustees shall be for whole life unless they resign or they are terminated.
- 8.2 The term of office of Co-opted and Patron trustees shall be for five years from the date of appointment unless they resign or they are terminated. However they can be re-appointed for the next term.

13. ANNUAL GENERAL MEETING :

13.1 The Trustees shall hold, every year before 30th September, an Annual General Meeting in which besides other work if any, the report of the previous financial year will be read and the accounts will be passed with two-third majority of the total strength.

13.2 Proper information of Annual General Meeting shall be given to each trustee well in time.

14. FINANCIAL YEAR :

The financial year of the Trust shall commence on 1st April and shall close on 31st March every year.

15. BANK ACCOUNTS :

The Trustees shall open account(s) in the name of the Trust in any Nationalized/Scheduled bank that shall be operated by joint signature of the Chairman and one of the Trustee authorized by the Board of Trustees for this purpose.

16. ACCOUNTS & AUDIT :

16.1 All the proper and regular books of accounts & registers for all the money received and spent for and on behalf of the trust shall be maintained regularly.

16.2 A Chartered Accountant will be appointed by the Board of Trustees, who will audit the accounts annually and his report along with the financial statements shall be put in Annual General Meeting for approval of the trustees.

17. INDEMNITY :

The Trustees shall be fully indemnified by the Trust against any action, claim, loss suffered or liability arising against them, on account of anything done by them in good faith pursuant to the power and authority conferred on them.

18. IRREVOCABILITY :

This Trust is irrevocable and none of the property of Trust will ever be re vested back either to the Founder Trustees or to other Trustees or persons.

19. AMENDMENT :

The provision of the Trust may be altered or amended by the Board of Trustees either unanimously or with the consent of 2/3 majority of the total strength.

20. **OTHERS :**

20.1 The trustees shall be at liberty to accept gifts, donations, voluntary contribution or aid from any person, firm, institution or Government for the use of the best interest of the Trust. They shall deposit such amount immediately in the Trust Fund.

20.2 The Trustees shall work in honorary capacity but they shall be entitled to reimbursement of expenses incurred by them in the conduct of their duties or in the promotion of the objects of the Trust or any expenses incurred on behalf of Trust.

20.3 No Trustee shall be entitle to take or accept any loan or advance from any person/ bank/ financial institution on behalf of Trust without having such authority in any meeting of the Trustees.

20.4 No Trustee shall be entitled to take loan or advance from Trust for himself or his family members in whatsoever form, nature or manner.

20.5 The Trustee may institute, conduct, defend, compound, compromise or abandon any legal procedure by or against the Trust or Trustees and allow time and indulgence for payment or satisfaction of any debt due or for any claims or demands by or against the Trust.

20.6 The Trustees may make or obtain payments from any person, court, any authority of law or Govt. departments on behalf of Trust.

20.7 The Trustees may purchase, construct, alter, lease, let out or sell any property in the longer interest of the Trust.

20.8 The Trustees may authorize any of the Trustee or any other person to appear before the Registrar, ~~Sub-registrar~~ or any other authority appointed for registration of deed or documents or other instruments and to execute present, admit and register such deed or document etc. in the interest of Trust.

20.9 The Founder Trustees may appoint General Manager/ Manager & other office bearers for Trust wing(s) in the larger interest of the Trust.

20.10 No trustee shall do any act without having any authority from the board of trustees.

- To get the accounts audited by an auditor appointed by the Trustees.




